

PREAMBLE

The Council of Homoeopathic System of Medicine, Haryana was established and constituted to regulate the qualification and to provide for the registration of practitioners of the Homoeopathic System of Medicine in the State of Haryana.

ARTICLES/MEMORANDUM OF ASSOCIATION

The Council of Homoeopathic System of Medicine Haryana was established and constituted for the purpose of carrying out the provisions of the Punjab Homoeopathic Practitioners Act, 1965 vide notification dated 31st March, 1970 consisting of seven members and later on expanded vide notification dated 4.2.1972 consisting of eleven members including its Chairman under section 3 of the Punjab Homoeopathic Practitioners Act, 1965. Total number of members of the Council is eleven including its Chairman. Out of 11 members, three members are nominated by the State Government and 8 members are elected from amongst the registered Homoeopathic Practitioners under sub-section (3) of section 3 of the Punjab Homoeopathic Practitioners Act 1965. Fourth time election of the 8 members of the Council has been conducted under the Haryana Homoeopathic Practitioners (Election) Rules, 1985.
